

STUDY ABROAD & EXCHANGE APPLICATION PACKET

This application packet is to be filled by Ahlia University 2nd year students interested in spending one semester, or up to one full academic year, during their 3rd year of study at any one of the university's partner institutions as part of the study abroad & exchange programme. The application must be completed prior to the end of the semester preceding the beginning the study abroad period.

- The home institution referred to throughout this packet is Ahlia University.
- The host institution referred to throughout this packet is the partner institution with which Ahlia University has a formal study abroad/exchange agreement.

General Instructions

- 1. You are highly advised to register with your respective embassy and/or the consulate/embassy of Bahrain in your study abroad destination.
- 2. You must provide the Admission & Registration Office with
 - a. Copy of your Letter of Acceptance / Offer
 - b. An original copy of your official transcript from the host institution.
 - c. Letter indicating the specific and exact period of study, and study mode (i.e. Fulltime, not online)
- 3. The transcript provided must be endorsed by the concerned authorities within a period of one semester once you have obtained your official transcript from the host institution.

Note: You must ensure that your name on the official transcript and any official documentation received from the host institution is identical to your name as it appears on your passport.

Instructions for Endorsement

- 1. The endorsement process has two aspects and can be done in one of the following ways:
 - a. Endorsement by the concerned Embassy in Bahrain / British Council.
 - b. Endorsement by the Ministry of Foreign Affairs in the Kingdom of Bahrain

Alternatively, students may opt for

- a. Endorsement by the Ministry or Department of Foreign Affairs
- b. Endorsement by the Cultural Attaché Office of the Bahraini Embassy

Note: The Ministry of Education in Bahrain normally provides a service to facilitate endorsement for certain countries. You may opt to make use of this service by contacting the Ministry or paying them a visit in Isa Town.

Annexure A - General Terms and Conditions of the Study Abroad & Exchange programme

- 1. The student will be governed by the rules and regulations of the host institution and country during the study abroad period.
- 2. Where the student has a 3rd party scholarship/sponsor, he/she shall be responsible for obtaining a letter of no objection for participation in the study abroad and exchange programme.
- 3. The student must bring an undertaking from his/her parent or guardian with regard to sufficient funds demonstrating ability to support the student for the period of study.
- 4. The student will normally pay an initial lodging fee prior to departure with regards to study in France (somewhere in the month of June/July if the student wants to study in the first semester of an academic year and in October/November if the student wants to study in the second semester). UK conditions vary, of which the student must ascertain at the time of application.
- 5. Where the student withdraws after paying accommodation-related fees, he/she may forfeit his/her money with regard to their study in France. With regard to the UK, conditions may vary and the student is advised to ascertain the conditions at the time of application.
- 6. The student shall be responsible for obtaining any visa and travel related documents necessary to pursue studies at the host institution prior to arrival at the host institution. Both institutions will assist the student, as necessary and within reason, in satisfying host-site visa requirements and any other necessary formalities.
- 7. Where the student fails to obtain immigration/visa approval, no party shall be liable for any forgone expenses related to the programme.
- 8. The student will be required to carry adequate health insurance and provide proof to the host institution that his/her insurance will cover the cost of healthcare during the period of study abroad prior to starting classes. Insurance must include: medical coverage for accidents and illness, repatriation of remains and medical evacuation.
- 9. The student may not register for any courses/modules that cannot result in any exemption, unless the Ahlia University Academic Department concerned approves such in writing.
- 10. The student will pay all customary tuition and registration fees, prior to departure, to his/her home institution (Ahlia University) once approved for participation in the study abroad and exchange programme.
- 11. The student agrees to pay tuition fees in accordance with Form B (Learning Agreement) as contained within this application packet, and regardless of the final exemptions outcome.
- 12. The student is fully responsible for the following expenses during his/her period of study at the host institution: books and other necessary course material fees, housing, meals, transportation (round trip and local ground), in addition to personal and medical expenses.
- 13. Where the student withdraws prematurely from the study abroad and exchange programme, the student will be liable to pay the tuition fees in accordance with Ahlia University's academic calendar and related rules and regulations governing course withdrawals. Ahlia University's refund policies shall apply. Additionally, the student will be at risk of being unable to register for any courses at the home institution during the same semester.
- 14. Where the student fails to complete the intended study abroad period due to deportation or dismissal, the student will be liable to pay the full tuition amount in accordance with Ahlia University's rules and regulations. The student may also be at risk of being unable to register for any courses at the home institution for a period of one semester.
- 15. Where the student fails in one or more courses at the host institution, the student will repeat the course(s) or its equivalent paying full fee(s) at the home institution upon return from the host institution.
- 16. The student will receive a credential (degree, diploma, or certificate) from Ahlia University only.
- 17. The student will not normally be entitled to any accreditation or exemptions of professional body qualifications that are acquired by the host institution.
- 18. The student is fully responsible for obtaining endorsement and/or authentication of his/her transcripts received from the host institution. Any charges incurred in processing the endorsement, as levied by the Ministry or any other party, are to be borne by the student.
- 19. The final course exemptions outcome will be subject to the endorsement of the Higher Education Council of Bahrain.
- 20. The Visiting/Exchange Students Policy shall apply to all participating study abroad and exchange students.
- 21. The student hereby grants consent for the transfer and use of personal data to facilitate his/her participation in the study abroad and exchange programme

Annexure B - Terms & Conditions of the Special Study Abroad Tuition Remission Scheme

- 1. The scheme only covers a specified number of students that fulfill the criteria specified by Ahlia University.
- 2. The scheme represents a tuition remission amounting to a maximum of 50% of tuition fees. This tuition remission can be added to an existing scholarship or tuition remission up to a maximum of 50% of total tuition fees.
- 3. The student will act as a student ambassador for Ahlia University and will agree to conduct him/herself accordingly, with full respect for the rules and regulations of the host institution and country. In such situations where student misconduct is found, the student will not only forfeit their participation in the scheme, but will additionally be liable for disciplinary action.
- 4. The scheme covers tuition fees only, and will not include any other amounts related to obtaining adequate health insurance, visas, housing, meals, transportation, registrations fees, books, course materials, endorsement and/or validation of transcript, or otherwise.
- 5. Where the student fails to complete the intended study abroad period, the tuition remission will be effectively rescinded and the student will be liable to pay the full tuition amount. The student may also be at risk of being unable to register for any courses at the home institution for a period of one semester.
- 6. Where the student fails more than 50% of the courses registered for, due to non-attendance, deportation, or dismissal due to academic misconduct, disciplinary issues etc. the tuition remission will be hereto rescinded, and the student will be liable to pay the full tuition amount.
- 7. Where the student fails in one or more courses at the host institution, the student will repeat the course(s) or its equivalent paying full fee(s) at the home institution upon return from the host institution. Any student found to have failed in one or more courses during a study abroad programme, may not be considered for participation in any study abroad related programme or Special Study Abroad Tuition Remission Scheme in future.
- 8. The student must ensure that he/she has met his/her obligations with regards to the services he/she has availed of, such as settling any pending payments related to rental for accommodation prior to returning to the home institution. Ahlia University is not responsible for any such liability. In cases where Ahlia University is informed of any such student related liability, Ahlia University may consider rescinding the tuition remission as the situation warrants.
- 9. The student must submit copies (to the directorate of international relations) of any and all relevant academic documents such as transcripts or letter of completion of the courses if and when such documents are made available by the host institution.
- 10. Upon completion of the study abroad period covered by the scheme, the student will submit a 2-3 page summary of their experience. The student will also agree to be available to discuss his/her experience with other students during promotional activities as organised by the directorate of international relations, if so requested.
- 11. The student participating in the scheme hereby consents to the publication of the summary of his/her experience, a photo, an appropriate quote or testimonial in institutional marketing materials, including the prospectus, brochures, newsletters, social media, and website.
- 12. The General Terms & Conditions of the Study Abroad and Exchange programme shall apply.
